AN ORDINANCE OF THE TOWN OF CORN, OKLAHOMA, PROVIDING FOR THE REGULATION AND THE OPERATION OF GOLF CARTS, ATVs AND SIMILAR VEHICLES IN THE TOWN OF CORN, OKLAHOMA, WASHITA COUNTY, AND DECLARING AN EMERGENCY.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN BOARD OF THE TOWN OF CORN, OKLAHOMA:

That Section 22-84, of Article 7, Operation of Golf Carts, ATVs, and Similar Vehicles, of Chapter 22, Traffic, of the Code of Ordinances of Corn, Oklahoma should be and the same is hereby to read as follows:

- 1. In accordance with the provisions of 47 O.S. Section 11-1116, The Town Board does hereby approve the operation of golf carts and utility vehicles, such as gators and side by sides, within the corporate limits of the Town of Corn, Oklahoma under the conditions set forth herein:
 - a. The operation of golf carts and utility vehicles shall occur only during daylight hours, unless equipped with head lights, brake lights, and they are in proper use.
 - b. Golf carts and utility vehicles can only be operated by licensed drivers. A licensed driver is defined as any driver who is duly licensed in any state to drive a motor vehicle. A motor vehicle is any wheeled vehicle which is designed for self-propelled movement.
 - c. Golf carts and utility vehicles may operate on state highways and/or county roads only if making a perpendicular crossing of any state highway and/or county road located within the boundaries of the Town of Corn, and only if residence on state highway or county road requires it to get to city street, and only if driving to school facility south of the Town of Corn, and only if filling of fuel at local equity requires such.
- 2. All former Ordinances, or parts of Ordinances, conflicting or inconsistent with the provisions of this Ordinance, are hereby repealed.

Emergency – Whereas, it being immediately necessary for the preservation of the peace, health and safety of the Town of Corn, Oklahoma, and the inhabitants thereof, that the provisions of this Ordinance be put into full force and effect, an emergency is hereby declared to exist, by reason thereof, this Ordinance shall take effect and be in full force from and after its passage, as provided by law.

THIS ORDINANCE PASSED AND APPROVED, AND THE EMERGENCY CLAUSE VOTED UPON SEPARATELY AND PASSED AND APPROVED, IN AN OPEN MEETING THIS 14th DAY OF APRIL, 2018 BY THE TOWN BOARD AND THE MAYOR BEING PRESENT AND VOTING ON THE PASSAGE OF THE ORDINANCE.
